RESOLUTION REQUESTING ALL PREGNANT WOMEN TO GIVE BIRTH AT THE NEAREST HOSPITALS OR BIRTHING CLINICS WITHIN THE MUNICIPALITY OF CARMEN, BOHOL.

“WHEREAS, the Municipality of Carmen, Bohol is a recipient and pilot municipality of the United Nation Funds for Population Activity (UNFPA) program;

“WHEREAS, to ensure protection of mother and baby before and after birth particularly those under post partum cases and to avoid infectious diseases that may cause mortality both to the mother and child, encouraging them to give birth at the nearest hospital or birthing clinic is imperative;

“WHEREAS, giving birth at the government medical facilities is a direct utilization of government facilities with the services of well trained and well-equipped medical personnel;

“WHEREAS, it is a means to have a harmonious relationship between the government and the constituents in extending quality and accessible health services;

“NOW THEREFORE, for and in consideration of the foregoing premises, be it resolved as it is hereby resolved in session duly assembled-

To request all pregnant women to give birth at the nearest hospital or birthing clinics of this municipality;

“RESOLVED FURTHER, to furnish copies hereof to the Municipal Mayor, Carmen, Bohol; Punong Barangays of Carmen, Bohol; Municipal Health Office, Carmen, Bohol; and all other concerned individuals and offices for proper information and appropriate action;
