SUBJECT : AFTER-TRIAL REPORT

Re : Case of MGEN CARLOS F GARCIA AFP

TO : Chief of Staff, AFP

DATE : 02 December 2005

1. Trial in the General Court-martial of MGEN CARLOS F GARCIA AFP (Ret) resumed from 0900 to 1500H today at JAGO Courtroom Nr 2, Torres Hall of Justice [JAGO], GHQ, AFP.

2. The President and the Members of the Court-Martial were present. A quorum being present, the trial proceeded as scheduled. The Accused was present, assisted by his Civilian and Defense Counsels; Members of the Prosecution Panel were present.

3. CLOSING ARGUMENTS: The Prosecution Panel and Defense Panel each presented their closing arguments in open court from 1000H to 12000H.

4. COURT RETIRED FOR DELIBERATIONS IN CHAMBERS: After the Closing Arguments, Special General Court-Martial retired to chambers for closed-door deliberations.

5. COURT RENDERS ITS VERDICT and SENTENCE: Upon resumption of the proceedings at 1500H, the Court promulgated its findings as follows, quoted verbatim from the transcript of stenographic notes:

"MGEN CARLOS FLORES GARCIA 0-5820 AFP the court in closed session upon secret written ballot 2/3 of all the members present at the time the voting was taken concurring the following findings. Finds you:

On Specification 1 of Charge 1 - Guilty except the words dollar deposits with Land Bank of the Phils, dollar peso deposits with Allied Bank, Banco de Oro, Universal Bank, Bank of the Philippine Island, United Coconut Planters Bank and Planters Development Bank.

On Specification 2 of Charge 1 - Guilty except the words except the words dollar deposits with Land Bank of the Phils, dollar peso deposits with Allied Bank, Banco de Oro, Universal Bank, Bank of the Philippine Island, United Coconut Planters Bank and Planters Development Bank.

On Specification 3 of Charge 1 - Guilty

On Specification 1 of Charge 2 - Guilty

On Specification 2 of Charge 2 - Guilty

And again in closed session upon secret written ballot 2/3 all the members are present at the time the votes was taken concurrently sentences you to be dishonorably discharge from the service, to forfeit all pay and allowances due and to become due and to be confined at hard labor at such place the reviewing authority may direct for a period of two (2) years. So ordered."
